

## **Terms and Conditions of Fourth Anniversary Party Game**

1. The promotion period of Fourth Anniversary Party Game ("**The Activity**") starts from 13 June 2024 to 31 July 2024, both days inclusive ("**Promotion Period**").
2. This promotion is only applicable to customers of Airstar Bank Limited (the "**Bank**") who have met the specified requirements defined in Clause 4 below ("**Eligible Customers**"). Subject to the terms and conditions listed here, Eligible Customers will be qualified to participate in the lucky draw of The Activity.
3. During the promotion period, each eligible customer will have a chance to win a lucky draw prize or a TIN 仔 Planet Card by participating in the draw of The Activity. If four TIN 仔 Planet cards with different themes are collected, an additional anniversary limited prize will be awarded ("**Party Game Prize**"). #### 10. Relevant Terms and Conditions for WeChat Pay HK E-cash Voucher:

10.1 Each Voucher will be issued in the form of a redemption code.

10.2 The redemption code is non-exchangeable for cash, vouchers, or other merchandise, and no refunds will be provided.

10.3 The redemption code cannot be used in conjunction with other promotions/offers/coupons.

10.4 The redemption code can only be used once, and expired or invalid redemption codes will not be reissued.

10.5 The redemption code is not applicable on third-party platforms except WeChat Pay Hong Kong.

10.6 The redemption code is valid within the date shown on the coupon code display page of the Bank APP. Winners must complete the redemption through WeChat Pay Hong Kong before the validity period.

10.7 After the redemption code is redeemed in WeChat Pay Hong Kong within the validity period, the E-cash Voucher will be valid within the date displayed on the E-

cash Voucher display page of WeChat Pay Hong Kong.

10.8 The relevant E-cash Voucher is provided by WeChat Pay Hong Kong. Airstar Bank Limited does not assume any responsibility in case of any disputes.

11. The Eligible Customers must maintain a valid Airstar Bank Account when the Party Game Prize is given.

15. In case of any ambiguity or disputes arising out of or under any of these terms and conditions or any communications, the decision of the Bank is final and conclusive in all circumstances.

16. These terms and conditions are governed by the laws of the Hong Kong Special Administrative Region. If there is any inconsistency or conflict between the English and the Chinese versions of these Terms and Conditions, the English version shall prevail.
